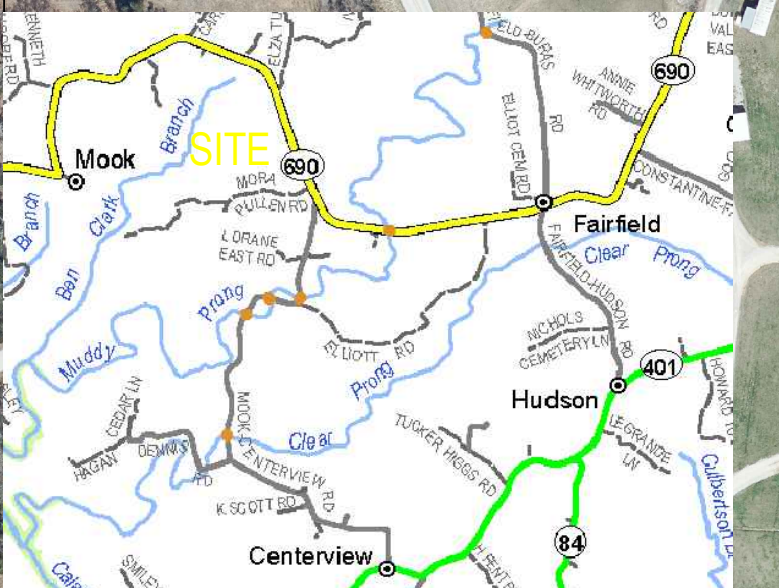
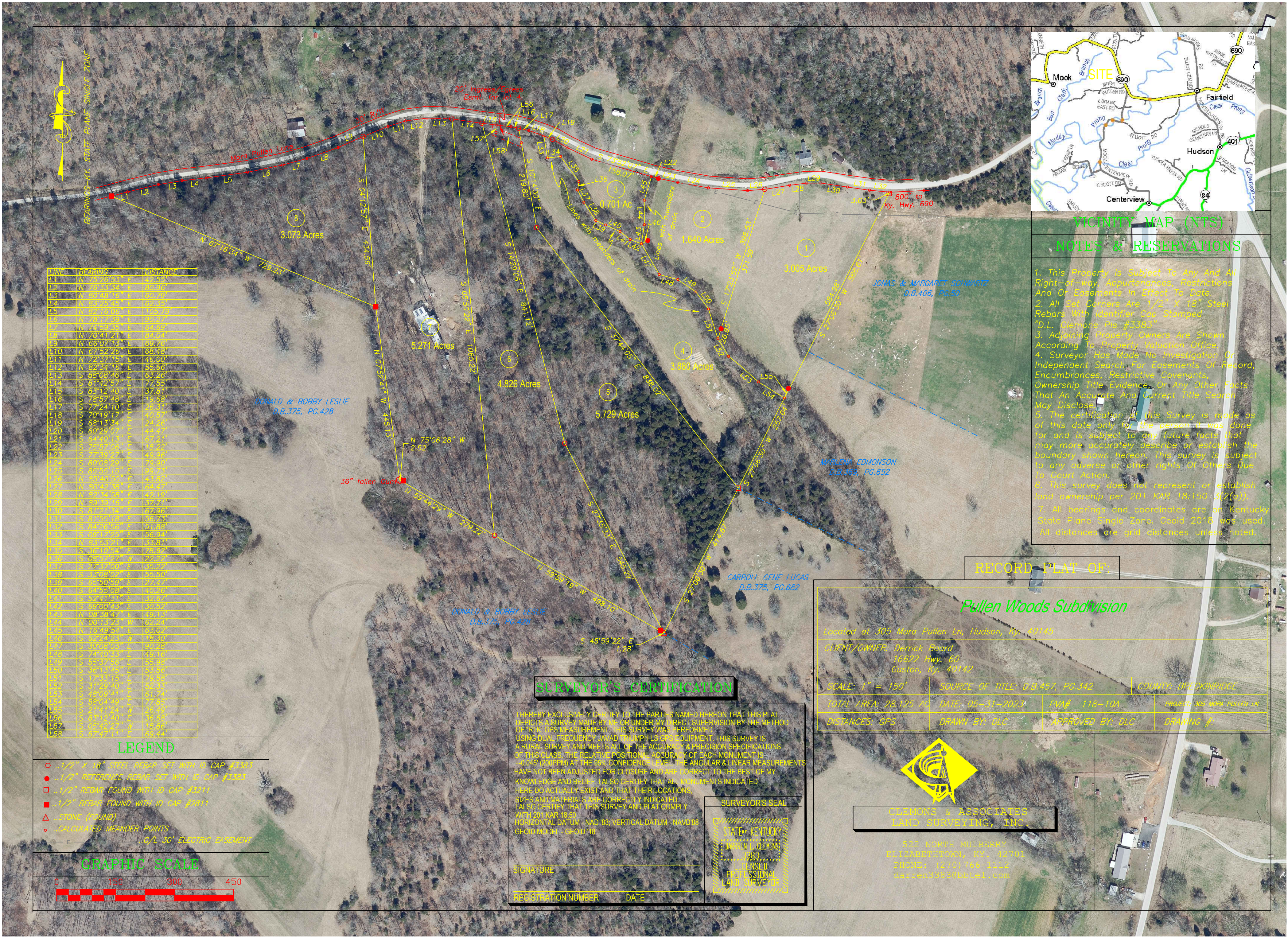




- ### VICINITY MAP (NTS)
