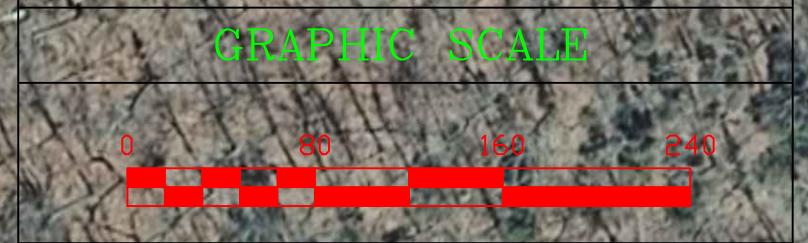


COUNTY MAP (NTS)

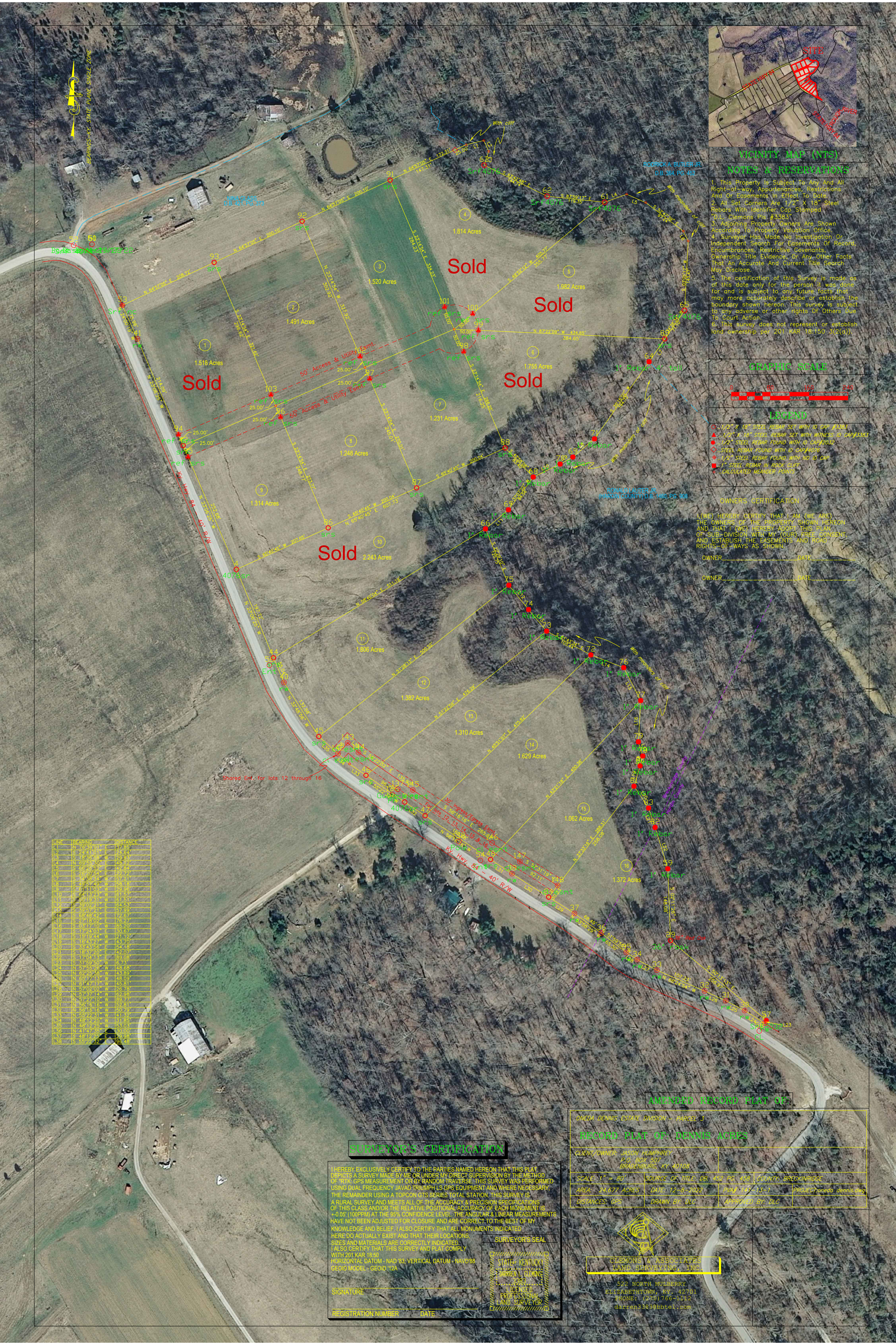
