DECLARATION OF RESTRICTIONS

This declaration of restrictions is made and executed by B.J. Espy, Sr., Peggy Espy, Joseph Lancaster, Beatrice Lancaster, Klein Hoskins, and Mary Hoskins, the owners of Rosetta Waterfront Estates.

Being Lots #2 through 42 and Lots #44 through #53 inclusive in Rosetta Waterfront Estates, a plat of which is recorded in Plat Book _____, Page _3__ in the office of the Clerk of the Breckinridge County Court.

- 1. All permanent residences shall have inside plumbing and shall have an inside area of not less than 600 square feet excluding carports, attached garages and porches.
- 2. In the construction of dwellings or other structures, exterior use of corrugated or "V" crimp metal, pulp, or tar paper, or asphalt composition is prohibited, with the exception of asphalt shingles on roof. All workmanship shall be equal to the best practices of modern, local area building contractors.
- 3. No continuing conditions shall be permitted which are noisome, odiferous, unsightly, smoky, dusty, unsafe, illegal, immoral, or offensive to a reasonable person.
- 4. No person shall be allowed to interfere with the free flow of the creek in any manner, nor shall any person be allowed to pollute the creek in any manner.
- 5. No house trailers measuring less than ten feet by forty feet shall be permanently installed on these lots.
- 6. No swine shall be raised on the premises and no junk or other litter will be permitted to accumulate on the premises.
- 7. These restrictions may be enforced by any individual lot owner, or by the Subdivider. In the event any lot owner fails to comply with the foregoing restrictions and costs are involved in correction of the infraction, a lien against the property may be taken for reasonable costs incurred in the correction of the infraction by the party expending such costs, including a reasonable attorney's fee.
